

TOWN OF CICERO RESOLUTION #1.02

AGREEMENT BETWEEN THE CITY OF SEYMOUR, TOWN OF SEYMOUR, TOWN OF OSBORN, TOWN OF CICERO, AND VILLAGE OF NICHOLS FOR A GRANT APPLICATION IN THE DEVELOPMENT OF A MULTI-JURISDICTIONAL COMPREHENSIVE PLAN

WHEREAS, the Town of Cicero Town Board, in cooperation with the City of Seymour, Town of Seymour, Town of Osborn and Village of Nichols agrees to participate in the preparation of the *Multi-jurisdictional Comprehensive Plan* for the general purpose of guiding and accomplishing coordinated, harmonious development within the northeastern quadrant of Outagamie County;

AND WHEREAS, the Town of Cicero Town Board acknowledges the requirements of Wisconsin's Comprehensive Planning Legislation including the adoption of the plan (s. 66.1001, Stats.), the benefits of comprehensive planning, and funding that would be awarded by the Wisconsin Department of Administration to financially assist the City of Seymour, Town of Seymour, Town of Osborn, Town of Cicero and Village of Nichols in preparation of Comprehensive Plans;

AND WHEREAS, the development of the *Multi-jurisdictional Comprehensive Plan* requires a financial contribution of \$6,120 from the Town of Cicero;

AND WHEREAS, meetings have been recently held with the participating communities and their consultant which discussed the planning process and community responsibilities, gathered public input, provided information and answered questions relative to the planning process;

AND WHEREAS, as part of participating in the this multi-jurisdictional planning process, the Town of Cicero will receive an individual planning document for review and adoption which addresses the requirements as specified under Wisconsin's Comprehensive Planning Legislation;

AND WHEREAS, the Town of Cicero acknowledges the receipt of a copy of the multi-jurisdictional comprehensive planning grant application and agrees to fulfill the goals set in Part III of the grant application;

AND WHEREAS, the Town of Cicero will commit to a single consultant for this multi-jurisdictional planning project.

NOW, THEREFORE BE IT RESOLVED that the Town of Cicero Town Board hereby agrees to participate in the development of a *Multi-jurisdictional Comprehensive Plan* in cooperation with other communities as listed in this resolution, pursuant to Wisconsin Statute s. 66.1001.
